- 4. The Council APPROVED, on the recommendation of the Advisory Committee to the Vice-Chancellor on Endowed Professorships, that the following Endowed Professorships be established:

in consideration of a donation of HK\$4.5 million from the Sun Chieh Yeh Heart Foundation and Professor C.P. LAU and with a matching fund from the University to fulfill the University commitment, together with the balance of HK\$11 million in the funds for the historically named "Sir David Todd Professorship in Medicine".
